

ARTICLES OF INCORPORATION OF VENTURE ENTERPRISES, INC.

ARTICLE I - NAME

The name of this Corporation is: VENTURE ENTERPRISES, INC.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.


