ARTICLE I - NAME

The name of the corporation is: CLIMATE FLOOR & TILE WHOLESALE, INC.

ARTICLE II - EXISTENCE

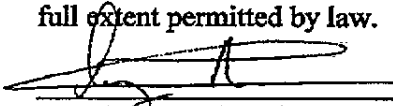

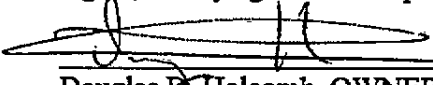
