The undersigned, for the purpose of forming a corporation under the provisions of Chapters 607, Florida Statutes, subscribes to the following Articles of Incorporation:

### ARTICLE I - NAME

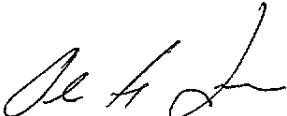
