ARTICLE I.

NAME

The name of this corporation is Emerald Crest of Gadsden County, Inc.

ARTICLE II.

PRINCIPAL OFFICE

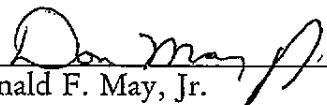
