ARTICLES OF INCORPORATION

OF

REGAL INDUSTRIES, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE - NAME

The name of the corporation is REGAL INDUSTRIES, INC.

ARTICLE TWO - PRINCIPAL PLACE OF BUSINESS

The principal place of business and mailing address of the corporation REGAL INDUSTRIES, INC. is 326 Cypress Road, Ocala, Florida 34472.

ARTICLE THREE - SHARES

The corporation REGAL INDUSTRIES, INC. is hereby authorized to have one-thousand (1,000) shares.

ARTICLE FOUR - REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 326 Cypress Road, Ocala, Florida 34472, and the name of its initial registered agent at such address if Eric Essick.

ARTICLE FIVE - INCORPORATORS

ARTICLE SIX - CORPORATE DURATION

This corporation shall have perpetual existence. The date and time of the

commencement of the corporate existence is at the time of filing the Article of Incorporation . by the Department of State.

- 4. In general, this corporation shall have and exercise all the powers conferred by the laws of the State of Florida upon corporations for profit. It is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner such general powers.

ARTICLE EIGHT - DIRECTORS
