ARTICLE I - NAME

Such indemnification shall continue as to a person who has ceased to be a director, officer, employee or agent, and shall inure to the benefit of the heirs and

personal representatives of such a person. An adjudication of liability shall not affect the right to indemnification for those indemnified.
