
#### **Article IX - Initial Officers**

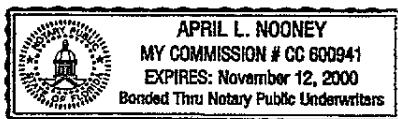
