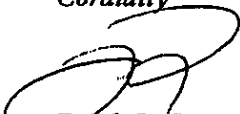
Please find herein the 2001 UBR for Maple Street Holdings, Inc., along with a check for \$ 158.75 towards the filing fee for the year 2001.
