The name of the corporation is Arizona Mortgage Company, Inc.

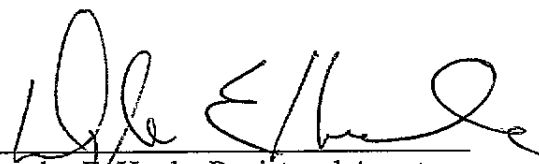
