ARTICLE I

NAME

The name of this corporation is JAXEL, INC., a Florida Corporation, and the place of business shall be located at:

DURATION

This corporation's existence shall be effective and commence upon the filing of these Articles of Incorporation, and shall continue in perpetuity.

ARTICLE III

PURPOSE
