THE UNDERSIGNED SUBSCRIBES TO THESE ARTICLES OF INCORPORATION COMPETENT TO CONTRACT, HEREBY FORM A CORPORATION UNDER THE LAWS OF THE STATE OF FLORIDA.

ARTICLE ONE:

CORPORATE NAME: THE NAME OF THE CORPORATION IS: BRAUN COMMUNICATION, INC,



ARTICLE TWO:

DURATION: THE CORPORATION SHALL EXIST PERPETUALLY UNLESS DISSOLVED UNDER LAW.
