ARTICLE I - NAME

The name of the Corporation is **TRADERS CHOICE COMMODITY CORPORATION.**

The Corporation shall have one director initially, whose name and street address is as follows:

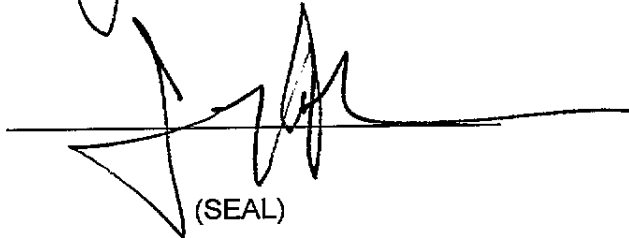

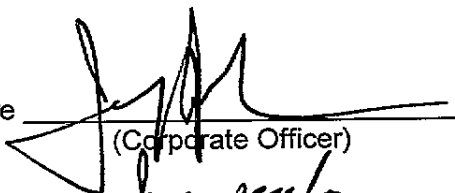

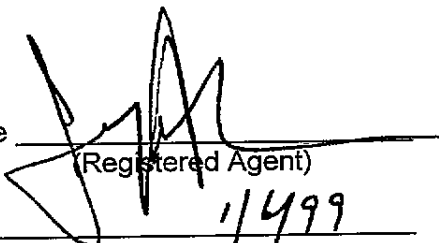
