ARTICLES OF INCORPORATION

OF

DANNIE JOHNSON, INC.

I, the undersigned, hereby associate for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida providing for the formation of a corporation for profit.

ARTICLE I Name and Principal Address

The name and principal address of the corporation shall be: DANNIE JOHNSON, INC., 1917 Williams Street, Jacksonville Beach, Duval County, Florida 32250.

ARTICLE II Duration

This corporation shall have perpetual existence.

ARTICLE III Purpose

The general nature of the business to be transacted by this corporation is as follows: To do all things which are authorized to be done by corporations organized under the laws of the State of Florida.

ARTICLE IV Capital Stock

The aggregate number of shares which the corporation is authorized to issue is One Hundred (100) shares. Such shares shall be of a single class, and shall have a par value of One Dollar
