#### ARTICLE VI

##### Initial Registered Office, Agent and Corporation

Notice must be given to the President of this Corporation not less than twenty-four (24) hours prior to the time set for the holding of the shareholders' meeting for the election of directors that said

shareholder intends to accumulate his vote at the election.

ARTICLE IX  
Incorporator
