The name of the corporation is PAD PRINTING TECHNOLOGY CORP., with its primary office at and a mailing address of 3003 62nd Avenue East, Bradenton, Florida 34203.

## ARTICLE II - EXISTENCE

This corporation shall commence its existence on the date of subscription and acknowledgement of these Articles and shall exist perpetually thereafter unless sooner dissolved according to law.

# ARTICLE III - NATURE OF BUSINESS

The general purposes for which this corporation is organized are:

- To purchase, acquire, hold, improve, develop, (a) sell, convey, assign, release, mortgage, encumber, lease, subdivide and deal in real estate of every kind and nature, improved and unimproved.
- To act as nominee or agent for the purpose of land acquisition, development, sales orfinancing.
