The undersigned Incorporator, for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the Corporation shall be Wilfong/Hughston, Inc., and it shall hereinafter be referred to as "Corporation".

ARTICLE II

The principal place of business and initial mailing address of this Corporation shall be: 2710 Orlando Drive, Unit 1, Sanford, FL 32771.
