#### **ARTICLE 1 - NAME**

The name of the Corporation is **CELILIA PANLILIO PINEDA**, M.D., **CORP.**, (hereinafter, "Corporation").

#### <u>ARTICLE 7 - CORPORATE CAPITALIZATION</u>

- 7.1 The maximum number of shares that this Corporation is authorized to have outstanding at any time is **SEVEN THOUSAND FIVE HUNDRED** (7,500) shares of common stock, each share having the par value of **ONE DOLLAR** (\$1.00).

All of the shares of stock of this Corporation may be subject to a Shareholders' Restrictive Agreement containing numerous restrictions on the rights of shareholders of the Corporation and transferability of the shares of stock of the Corporation. # **ARTICLE 10 - POWERS OF CORPORATION**
