ARTICLE I - NAME

The name of this corporation is THE CORWIN COMPANY and its principal place of business is 10016 North Leisure Lane, Jacksonville, Florida, 32256.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing upon the filing of these articles of incorporation with the Secretary of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - STOCK

This corporation is authorized to issue 1,000 shares of one dollar (\$1.00) par value common stock.


