ARTICLE I. NAME

The name of this corporation is Sorin Dimitriu, D.D.S., P.A.

ARTICLE II. DURATION

This corporation shall have perpetual existence commencing on January 8, 1999.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of engaging in the practice of dentistry, and all its fields of specializations; for the purpose of engaging and rendering the professional services involved only through its officers, agents and employees who shall be in the medical practice in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this corporation; for the purpose of investing its funds in real estate, mortgages, stocks, bonds and any other type of investments permitted by law; for the purpose of engaging in no other business other than the rendition of the professional services specified herein; and for the purpose of doing everything necessary and proper and accomplishing the purposes herein set forth.

ARTICLE IV. CAPITAL STOCK

This corporation is authorized to issue 1000 shares of \$1.00 par value common stock which shall be designated "Common Shares." Shares of the corporation's stock and certificates shall be issued only to doctors of dentistry in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this corporation.

ARTICLE V. PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 1500 East Hillsboro Boulevard, Suite 208, Deerfield Beach, Florida 33441 and the name of the initial registered agent of this corporation at that address is Sorin Dimitriu. 
ARTICLE IX. INDEMNIFICATION

ARTICLE X. AMENDMENT


