ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF NADIF OF SOUTH BEACH, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is NADIF OF SOUTH BEACH, INC. (the "Corporation"), document number P99000003232, filed on January 12, 1999.
- 2. The following Amendment to the Articles of Incorporation was adopted by the all of the Directors of the Corporation and by all of the Shareholders of the Corporation, the number of votes cast being sufficient for approval, on November 1, 1999 in the manner prescribed by Section 607.1003 of the Act:
