### ARTICLES OF INCORPORATION OF HINKLE BAIT & TACKLE, INC.



The undersigned, acting as incorporator under and by virtue of the laws of the State of Florida, and particularly the Florida General Corporation Act, as provided in Chapter 607, Florida Septimes, and any acts supplementary thereto, adopts the following Articles of Incorporation for such corporation.

#### **ARTICLE I**
