

ARTICLES OF INCORPORATION OF ELIXON, INC.



ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is ELIXON, INC., and the principal address and principal place of business is P.O. BOX 152761, TAMPA, FLORIDA 33684.

ARTICLE II - REGISTERED OFFICE AND AGENT
