

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF MEDIA RESEARCH, INC.

Pursuant to the provisions of Florida law, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the Corporation is MEDIA RESEARCH, INC.
- 2. The following Amendment of the Articles of Incorporation was adopted by the Shareholders of the Corporation on the 12th day of January, 1999, in the manner prescribed by Florida law.

Article III of the corporate charter filed on the 12th day of January, 1999, is amended as follows:

"ARTICLE III Capital Stock

This corporation is authorized to issue ONE MILLION (1,000,000) shares of ONE CENT (\$0.01) par value common stock, which shall be designated "Common Shares."

- 3. The number of shares of the Corporation outstanding at the adoption was one hundred (100), and the number of shares entitled to vote thereon was one hundred (100).
- 4. The number of shares voted in favor of such Amendment was one hundred (100), and the number of shares voted against such Amendment was none.
- 5. This Amendment shall become effective immediately upon filing with the Department of State of Florida.


