To Whom It May Concern:

I am writing you this letter to request that you wave the reinstatement fee for the year 2001. We did not receive the renewal for the UBR for the year 2001 due to an incorrect address, which I had corrected in 2000 (enclosed is a copy of a document from the Department of State showing the new address which is 10372 SW 114th Terrace, Miami, FL 33176).

We got a reminder from our CPA, not to forget to pay our UBR by May 2002. I then called our CPA and told him that we never received the form and he told us that we needed to contact the Department of State, which I did. When I spoke to Kathy at the Department of State she told me that our business had been dissolved due to no payment in 2001, and an incorrect address was on file. I then faxed Kathy a copy of the document showing that it had the new address. She told me to send a payment of \$300.00 for this year and last year and to write a letter explaining why last year was not paid.

I did not know that the UBR was to be paid yearly to keep the business in an active status. If we had not received the reminder from our CPA, the same situation would of happened this year.
