The undersigned, all of whom are duly licensed to practice law in the State of Florida, desire to form a professional corporation in accordance with Chapters 607, Florida Statutes, and the Florida Professional Service Corporation Act, adopt the following Articles and hereby present these Articles of Incorporation for the formation of the corporation.

ARTICLE I - NAME

The name of this Corporation is:
