Dear Sir or Madam:

We are the Certified Public Accountants of the above noted Florida corporation and I am the Registered Agent for such. I am also the CPA for its officer Boris Kotko who reside outside the United States most the each year.

As a result of the receipt of a Notice of Intent to Dissolve another corporation with Boris Kotko as the officer, we researched the above noted entity which has the same officer and found that it had been administratively dissolved back in 2003. This occurred because the corporation never received an annual report or postcard for filing its 2003 annual report.

We would like to reinstate BMK & ASSOCIATES, INC. Enclosed with this letter is the properly completed the REINSTATEMENT APPLICATION.

At this time we would also like to request a waiver of the penalty for non-filing based on the fact that we never received the annual report or postcard for filing the 2003 annual report.

In so doing we would like to provide an explanation for why the annual report or postcard was never received.

1. Enclosed you will find a copy of the filed annual report for 2001. You will note that Mr. Kotko attempted to change all the addresses to 9500 S Dadeland Blvd #508, Miami, FL 33156. He however made the mistake of not noticing that he also needed to change the mailing address (which is supposed to be the same as the principal address).
2. Enclosed you will also find a copy of the annual report Mr. Kotko filed for 2002. Upon review you will note two items that further indicate that the annual report was not received.
  - The 2002 filed annual report is manually prepared.
  - The principal address was properly filled out but the mailing address was left blank.
