

**ARTICLES OF INCORPORATION**  
**OF**  
**FISCHER & FORMAN, INC.**

**ARTICLE I**

The name of the corporation is FISCHER & FORMAN, INC. (hereafter the "Corporation").

**ARTICLE II**

The address of the principal office and the mailing address of the Corporation is 8061 W. McNab Road, Tamarac, Florida 33321.

**ARTICLE III**

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

**ARTICLE IV**

The Corporation shall hold a special meeting of shareholders only:

1. On call of the board of directors or persons authorized to do so by the Corporation's bylaws; or


**ARTICLE VII**
