
Dear Sir or Madam:

The original Uniform Business Report for the above referenced corporation was sent to the owner in France early during 2000. Despite our repeated efforts to trace it, it never arrived in France.

In late April, we contacted your office by phone and we were told it was permissible to prepare the form on a photocopy of the only blank form we had available to us, and that we would be granted another 30 days to file the form. We immediately sent it France via Federal Express. Although Federal Express offered us 2-day service, the package did not arrive at its destination until 7 days had passed. By this time the owner had left the country on a business trip. The package had to be forwarded to him in Monaco. After these arrangements were made, we contacted your office again to explain the situation. We were told that due to the circumstances, we would again be granted additional time to file the form.
