The undersigned, for the purpose of creating a corporation under the laws of the State of Florida, does hereby adopt the following Articles of Incorporation:

FIRST ARTICLE

The name of the corporation is DESTIN BUSINESS FORMS, INC.

SECOND ARTICLE

The purpose of the corporation is to do any and all lawful business not inconsistent with the laws of the State of Florida.

THIRD ARTICLE

The corporation is authorized to issue One Thousand (1,000) shares of stock with a par value of one dollar (\$1.00) each. Such stock shall be of a single class.

FOURTH ARTICLE

The corporation's principal office is at 307 Lan Rob Lane, Destin, Florida

The corporation's mailing address is P.O. Box 86, Destin, Florida 32540.

The registered office of the corporation is 307 Lan Rob Lane, Destin, Florida, the same address as the corporation's principal office. The registered agent is EDDIE D. WOLVERTON

SIXTH ARTICLE

These Articles of Incorporation may be amended in the manner provided by law. The presence, in person or by proxy, of shareholders holding of record fifty-one percent (51%) of the total number of shares of the Corporation, then issued and outstanding and entitled to vote, shall be necessary and sufficient to constitute a quorum for the transaction of any business at any meetings of shareholders of the Corporation.

SEVENTH ARTICLE

Any director may be removed with or without cause by a vote of the holders fifty-one percent (51%) of the shares then entitled to vote at a special meeting of the shareholders called for that purpose.






