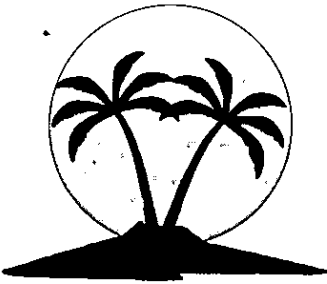

We recently learned that Florida Choice of Naples, Inc. was administratively dissolved. This came at a great surprise since we remembered filing the report and knew the check had cleared the bank.

Upon learning that the corporation was dissolved, we sent you a copy of the cancelled check showing that the return was filed timely. You have now responded stating that the return was never signed. In calling your office, we have been told that you did receive the return timely, cleared the check, but the return was not signed in box 13.

We were not aware of this and do not have any returned copy of the original annual report. We did sign box 3 and our copy is signed on box 13 but you state your copy was not signed. Because we did not receive any notification of this prior to now, and because we did file the return timely, please accept the original return as timely filed and abate the reinstatement penalty.
