ARTICLES OF INCORPORATION

OF



SALDANA GROUP, INC.

The undersigned incorporator, JOSE W. SALDANA, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is SALDANA GROUP, INC.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of the corporation is 36 BAY COVE, FREEPORT, FLORIDA 32439.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.

ARTICLE IV - CAPITAL STOCK
