ARTICLE I. NAME

THE GENERAL NATURE of the business to be transacted by this Corporation shall be:
Wholesale and export of heavy equipment and truck parts.

- A. To engage in every aspect and phase of the business of operating a heavy equipment
And truck parts wholesale and export business.

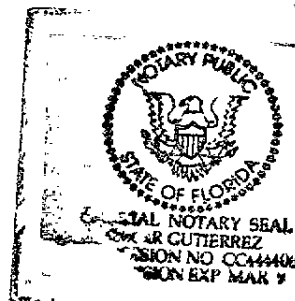


