ARTICLES OF INCORPORATION

The undersigned does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida General Corporation Act.

FIRST: The name of the corporation (hereinafter called the "Corporation") is Intelligent Data Solutions, Inc., at 800 W. Cypress Creek Road, Suite 240, Fort Lauderdale, Florida 33309.

SECOND: The duration of the Corporation shall be perpetual.

THIRD: The purpose for which the Corporation is initially organized shall be to transact any lawful business for which corporations may be incorporated under Florida law.

FOURTH: The aggregate number of shares that the Corporation shall have authority to issue is Ten Thousand (10,000) common shares with a par value \$0.01 per share.

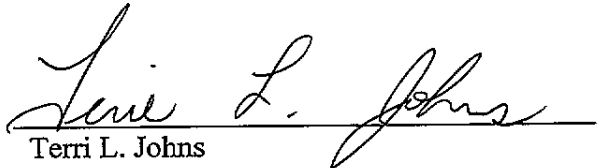
