# ARTICLES OF INCORPORATION OF NICHOLAS G. SADAKA, P.A.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

#### <u>ARTICLE I</u>

The name of the corporation shall be NICHOLAS G. SADAKA, P.A.

#### ARTICLE II

The bylaws of the corporation may be amended by majority vote of either the directors or the shareholders.
