ARTICLES OF INCORPORATION OF

EQUITABLE SUCCESSOR BANK (A Successor Institution)

The undersigned, acting as directors for the purpose of forming a successor institution under and by virtue of the Laws of the State of Florida, adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be Equitable Successor Bank and its initial place of business shall be 633 South Federal Highway in the City of Fort Lauderdale, in the County of Broward, and the State of Florida.

ARTICLE II

This corporation shall be organized as a successor institution in accordance with Section 658.40(4), Florida Statutes.

ARTICLE III

The total number of shares authorized to be issued by the corporation shall be 143. Such shares shall be of a single class and shall have a par value of \$7.00 per share. The corporation shall begin business with at least \$1,000 in paid-in capital stock to be divided into 147 shares. The amount of surplus with which the corporation will begin business will be not less than \$200 and there will be no undivided profits. All of these items (capital stock, surplus, and undivided profits) shall be paid in cash.

ARTICLE IV

The term of which said corporation shall exist shall be one (1) year.

ARTICLE V
