Name

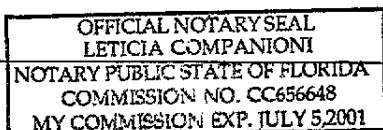


