*Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:*

**First:** Amendment adopted: Article Seven 400 shares of the original stock are to be sold to Thomas L. Titshaw. His title is Vice President.

**Second:** This amendment provides for an exchange of issued shares, provisions for implementing the amendment is not contained in the amendment itself, are as follows:

Thomas L. Titshaw will pay a total of \$ 35,0000.00 for these shares over a period of no more than 5 years. The cost per share is valued at \$ 87.50. These shares will be held in Escrow until paid in full.
