## ARTICLES OF INCORPORATION OF

MILLENNIUM BANK

The undersigned, acting as directors for the purpose of forming a corporation under and by virtue of the Laws of the State of Florida, adopt the following Articles of Incorporation.

#### ARTICLE I

The name of the corporation shall be MILLENNIUM BANK and its initial place of business shall be at 4340 W. Newberry Road in the City of Gainesville, in the County of Alachua, and State of Florida.

#### ARTICLE II

The general nature of the business to be transacted by this corporation shall be: that of a general commercial banking business with all the rights, powers and privileges granted and conferred by the Florida Financial Institutions Codes, regulating the organizations, powers, and management of banking corporations.

#### ARTICLE III

The total number of shares authorized to be issued by the corporation shall be Two Million (2,000,000). Such shares shall be of a single class and shall have a par value of Five and No/100 Dollars (\$5.00) per share. The corporation shall begin business with at least Two Million Two Hundred Thousand and No/100 Dollars (\$2,200,000.00) in paid-in common capital stock to be divided into Four Hundred Forty Thousand (440,000) shares. The amount of surplus with which the corporation will begin business will be not less than One Million Two Hundred Fifty Thousand and No/100 Dollars (\$1,250,000.00) and the amount of undivided profits, not less than Six Hundred Fifty Thousand and No/100 Dollars (\$650,000.00) all of which (capital

stock, surplus, and undivided profits) shall be paid in cash.

Each shareholder of the corporation shall have the right to purchase, subscribe for, or receive a right or rights to purchase or subscribe for, at the subscription price offered to the general public, a pro rata portion of any stock of any class the corporation may issue or sell.

### ARTICLE IV

The term for which said corporation shall exist shall be perpetual unless terminated pursuant to the Florida Financial Institutions Codes.

#### ARTICLE V

The number of directors shall not be fewer than five (5). A majority of the full board of directors may, at any time during the years following the annual meeting of shareholders in which such action has been authorized, increase the number of directors by not more than two (2) and appoint persons to fill resulting vacancies.
