ARTICLES OF INCORPORATION
OF

DAVID YUDENFREUND, CPA, P.A.

The undersigned incorporator, who is licensed or otherwise legally authorized to practice public accountancy in the State of Florida, hereby proceeds to form a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act, and hereby adopts the following Articles of Incorporation for such Corporation.

ARTICLE I

The name of the corporation shall be DAVID YUDENFREUND, CPA, P.A. The mailing address of this Corporation shall be P.O. Box 7161 Boca Raton, Florida 33487.

ARTICLE II

The purpose of this Corporation and the general nature of its business are as follows:

a) To engage in the practice of public accountancy as a professional corporation and to provide services incident thereto.

b) To own property, enter into contracts and carry on any activity necessary or incidental to the accomplishment or furtherance of rendering professional accounting services.

c) To do everything necessary, proper or convenient for the accomplishment of any of the purposes herein set forth, as to do every other act incidental thereto which is not forbidden by the law of the State of Florida or by the provisions of these Articles of Incorporation.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one hundred (100) shares of common stock having a nominal or par value of ONE DOLLAR (\$1.00) per share. None of the shares of this Corporation may be issued to anyone other than an individual who is duly licensed to practice public accounting in the State of Florida or otherwise legally authorized to practice public accounting in the State of Florida.

ARTICLE IV

The term of this Corporation is perpetual.

ARTICLE V

The name and address of the person signing these Articles of Incorporation as an incorporator, who is duly licensed in the State of Florida to practice public accounting is:

ARTICLE VII

ARTICLE VIII

No shareholder may sell or transfer his or her shares in this Corporation except to another individual who is eligible to be a shareholder of this Corporation under Florida law.

ARTICLE XI

If any officer, shareholder, agent or employee of the Corporation who has been rendering professional services for this Corporation becomes legally disqualified to render such professional services within Florida or accepts employment that places restrictions or limitations upon his or her continued rendering of such professional services, then this Corporation shall require him or her to comply with the Florida Professional Service Corporation and Limited Liability Company Act by severing all employment with and financial interests in this Corporation.

ARTICLE X

These Articles of Incorporation may be amended in the manner provided by Florida law.


