

ARTICLES OF INCORPORATION

OF

ARTICLE ONE - NAME & ADDRESS

The name of the Corporation is **WESTON WOODWORKING INC.**, and the principle place of business of this corporation shall be: PO Box 40044, 2565 24th Avenue North, St. Petersburg, FLORIDA 33743-0044.

ARTICLE TWO - NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.
