ARTICLES OF INCORPORATION OF HOLIDAY COURT, INC.

ASECONANIA PARA SIATA The undersigned, CHRISTINE F. WRIGHT, files in the Office of the Secretary of State of the State of Florida, for the purpose of forming a corporation for profit, in accordance with the laws of the State of Florida, these Articles of Incorporation, as by law provided.

I. NAME:

The name of this Corporation shall be: HOLIDAY COURT, INC.

II. BUSINESS:

The general nature of the business and business to be transacted are as follows: To transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida of the United States.
