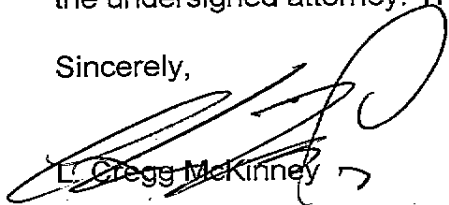

ARTICLES OF INCORPORATION FOR
ANGLIN & COMAR ENTERPRISES, INC., a Florida corporation

The undersigned Incorporators, **Ms. Jennifer Comar** and **Mr. Alex Anglin**, hereby form a corporation under Chapter 607 of the laws of the State of Florida.

Article I.
NAME & PRINCIPAL PLACE OF BUSINESS

The name of the corporation shall be : ***ANGLIN & COMAR ENTERPRISES, INC.***

NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

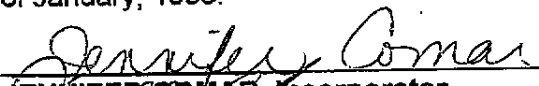

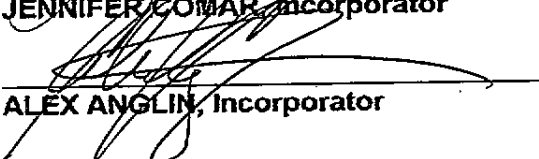
