ARTICLES OF INCORPORATION

OF

ContinuingEducation.com, Inc.

The undersigned Incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the Corporation is **ContinuingEducation.com**, **Inc.** ("Corporation"). The principal place of business of the Corporation shall be P.O. Box 15492, Tallahassee, Florida 32317. The name of the registered agent is Igler & Dougherty, P.A., 1501 Park Avenue East, Tallahassee, Florida 32301.

ARTICLE II. NATURE OF BUSINESS

The Corporation may engage in or transact any and all activities and businesses permitted under the laws of the United States and of the State of Florida or any other state, county, territory or nation.
