ARTICLE I. NAME

The name of the Corporation is Jack R Loisel, P.A.

ARTICLE II. DURATION

This Corporation shall have perpetual existence.

ARTICLE III. PURPOSE.

This Corporation is organized to transact and carry on any activity or business permitted under the laws of the United States and the State of Florida. as Real Estate Agent Sub-Contractor

ARTICLE IV. CAPITAL STOCK

This Corporation is authorized to issue 1,000 shares of one (\$1.00) par value common stock.

ARTICLE V. MANAGEMENT

A. Pursuant to the provisions of Section 607.111, Florida Statutes, as the same exists upon the adoption of these Articles of Incorporation, the business of this Corporation may be managed by the shareholders of the Corporation, rather than by a Board of Directors.


ARTICLE VIII. PRE-EMPTIVE RIGHTS.






