ARTICLE I - NAME

The name of this corporation is the BAYOU COMMUNICATION, INC.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing on January 14, 1999.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of operating to WFSH 1340 AM radio station in Niceville, Florida, such other radio stations it may acquire and related services and for transacting any or all lawful business as allowed under the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 10,000 shares of One Dollar (\$1.00) par value common stock, which shall be designated "common shares".
