## Article X Stock Restrictions

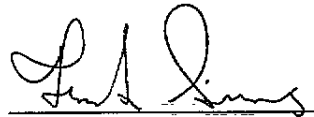

## Article XII Amendment(s)

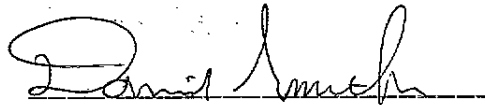
These articles of incorporation may be amended in any manner provided by law.
