The undersigned incorporator to these Articles of Incorporation, a natural person competent ORIDA to contract, hereby associates himself to form a corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of this corporation is OFI, INC.

ARTICLE II NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is buying, leasing and maintaining aircraft.
