# ARTICLES OF INCORPORATION OF PREMIUM HOLDINGS INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby organizes and incorporates a corporation under the laws of the State of Florida.

# <u>ARTICLE I. NAME</u>


