Statement of Fact

I, Tina Ann Dominguez, wish to make a statement of fact regarding business document P99000004658, ONIT Enterprises, INC. I was employed as Vice President since October 1, 2016, Faustino Dominguez, President. The original Articles of Incorporation for ONIT Enterprises, INC. were filed on January 15, 1999, listing Faustino Dominguez as President, with Faustino Dominguez being the only board member. Walter Burnside, Esq, was listed as the incorporator of the initial Articles of Incorporation. Faustino Dominguez has acted as President of ONIT Enterprises, INC. since the original articles were filed. Mr Burnside has not had any part in the filing of documentation for ONIT Enterprises, INC. since the initial filings were made.

In April 2018, as part of my responsibility for the maintenance of company documentation, I filed Articles of Amendment to the Articles of Incorporation for ONIT Enterprises, INC. naming Faustino Dominguez, President, and Tina Ann Dominguez, Vice-President. Thereby creating a board of directors. I was directed by Faustino Dominguez to indicate that the amendment was adopted by the incorporators without shareholder action, which I did.


In June 2019, I filed Articles of Amendments to Articles of Incorporation of ONIT Enterprises, INC., which included address changes, change of the registered agent, changes in shareholdings for the company (Tina Ann Dominguez owning 50% and Faustino Dominguez owning 50%). These changes were agreed upon by Vice President, Tina Ann Dominguez and President, Faustino Dominguez.

In July 2019, Faustino Dominguez filed false documentation removing my name from the board of the company, along with filing a letter alleging fraud on my part. That same month, I received a notice from Anthony Cruz, Jr. Esq, stating he was retained as counsel for the business and that I was terminated from my position within the company.

Attached is a text message from Faustino Dominguez stating agreement with all actions taken on my behalf regarding the document filings in June 2019 along with the original letter of employment

I hold that all actions taken on my part were lawful and in accordance with Florida Statutes and the Florida Business Corporations Act. I also hold that actions and filings done by Faustino Dominguez in July 2019 are in violation of Florida Statute 817.155, and Florida Business Corporations Acts 607.0808, 607.0809, and 607.08101.
