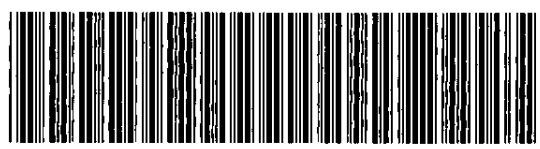

The file date of the Articles of Incorporation was January 15, 1999.


**Article 4**

The effective date of dissolution is March 31, 2009.

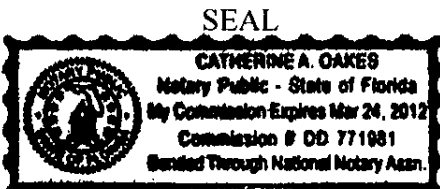


